5. **Youth Campus Update** – The lease and tripartite agreement has been signed by all parties. Invitation to tender went out on February 4, 2016. General contractor walk through took place on February 23, 2016. The tender review is set for March 14-25. The selection committee consists of eight people who have been instrumental to the project. Neil has offered legal assistance if necessary and will meet with Steven Levergent. Steve's commitment is now finished. He has been very instrumental in the process and should be recognized for his commitment. Dale and Todd will decide how to acknowledge his work. February 23, 2016 meeting with Avi Habinski(Alberta Infrastructure) and Danny Breten (CBE), initial discussion to facilitate transition to be reviewed in fall of 2016. Ground breaking ceremony date will be determined and announced when the minister is able to attend.

#### 6. Committee Reports

- Government/Stampede Liaison Linda CAA 15 year charter renewal will expire in 2028. Two new charter applications were turned down. Boyle Street Charter received a 5 year renewal. Charter public schools are still viewed as private schools. Linda is reviewing funding for charter schools. TAAPCS has requested a meeting with the minister. Education Advisory Committee(EAC) will appoint a representative for TAAPCS. Linda shared February 20, 2016 newspaper articles "Master Plan on Track" and CMLC to Weigh In", and a Calgary Stampede article of the partnership formed in East Village and the benefits of a Tax Incremental Financing 20 year plan.
- CAAS Foundation and Community Liaison Mary Anne "Evening of Arts and Inspiration". Fundraising event May 13, 2016 at Victoria Pavilion with Calgary Stampede's caterer and bar services. There will be a silent auction component, entertainment, food stations, door prizes and more. Volunteers will be needed with this event. This event will be endorsed by high profile individuals and companies, and will be an excellent opportunity for sponsors to advertise. Early bird and regular ticket prices will be announced.
