**Fall Budget Update Report** – Jan – The fall budget update, like the spring budget is balanced. Changes to the budget could be affected by enrolment, changes to bus ridership, staffing changes and actuals verses spring estimates. The budget was shared electronically with directors.

**Youth Campus spending update** – Also shared electronically, spending to date for the youth campus is at \$3,466,508.25. This is supported 100% by Alberta Infrastructure and does not affect the operations budget of the school.

- **7. TAAPCS Update Dale -** a new Executive Director has been hired for TAAPCS Kathy Ryerson. Kathy was formerly with College of Alberta School Superintendents and is supportive of Charter schools and aware of government issues with charters. Committees Governance and Directors. Director input for TAAPCS is greatly appreciated.
- **8.** Glenmeadows and Knob Hill move update Dale has met with CBE a few times. Construction at Glenmeadows will begin in April, and it is hoped it will not affect programming. Student care relocation is being investigated for summer program. If washrooms are complete in time at Knob Hill, it could be an option. Other school options rather than Knob Hill cannot be considered with a freeze on enrolment cap. Presently engaging with movers for October move. To avoid extra moves, GM students may start 2017 year at Knob Hill and middle school at Glenmeadows until October break, moving to Youth Campus then. No summer clean will be done at Glenmeadows in 2017.
