1. Call to order – 6:05
2. Approval of the Agenda – Considered Approved
3. Approval of May 18, 2021 minutes of Regular Meetings of the Board of Directors – Considered Approved
4. Audit Committee – Neil – Audit Committee met today, and the monthly financials look as expected. The second piece is the RFP for IT. The school received 4 proposals and have narrowed it down to 2 with an inperson presentation later this week. Cudos to Cole for the process.

5. Superintendent Report – Dale - Stampede – due to their financial obligations they have put a hold on any allotment of land, which has changed our approach with portables. We look forward to working with the new CEO on a new a plan moving forward.

We sent a letter to the minister, and a conference call will be held Thursday to discuss options. We should know more by the end of the week. We are hoping they will be over the disappointment by the time the discussion is had that we can move positively

forward. If the government provides the modules at Knob hill we will have sufficient room for High school.

We continue to work with the government with other issues including SLS funding and curriculum. They have provided TAAPCS some money to provide feedback on the Curriculum. Our intent is to focus on the arts first.

As we continue our succession planning, we look at the scope of the Superintendent. We are being proactive and building our leaders by emowering them with more responsibility. We are adding a full time Acting Vice Principal to support Michelle and manage the highschool programing. We are also adding an Acting Vice Principal role at Knobhill to work with Kim as well as literacy. All are acting positions. All are internal promotions.

Michelle walked through the Education Plan with the board.
