- 2. Approval of the Agenda Considered Approved
- 3. Approval of October 20, 2020 minutes of Regular Meetings of the Board of Directors Approved with an addition to section 7- "...and the board recommends their appointment"
- 4. Audit Committee Neil The Audit committee met with KPMG to discuss the 2020 AFS which has also been provided to the board. There were no issues steming from the audit from a management perspective. KPMG did have a concern with the Alberta Educations templates as they did not comply with Public Sector Accounting Standards (PSAS), and while this has nothing to do with management it will be described as a misstatement on there report. - 5. Superintendent Report Dale We will be discussing the Draft AERR Report at the AGM. No further update at this time.
- 6. Advocacy
 - Government Relations Committee Ken The Alberta School Council
 Association (ASCA) has passed 3 motions that negatively target Charter Schools.
 They currently receive over 600k in funding from the Alberta government.
 Charter school councils have started an advocacy committee to help fight these issues. TAAPCS had a meeting with the deputy minister to clarify our stance these motions.
 - Capital Plan/Infustructure Committee Jim Discussions with government are on going.
 - Community Engagement Committee Joshua Janice gave a great update with Calgary Reads and our yr 10 students. Now that things are settled Josh will be interviewing yr 10s directly to find out their priorities to help connect them to community opportunities.

Katherine met with Dale regarding staff stress and anxiety, to ensure they have all the tools they need. She has a connection that can help teachers with some mindfulness exercises.

- 7. Governance Committee John We have asked Torrin McNeill to join the committee as another voice to the group.
