4. Audit Committee – We met to discuss our current finances. Our current estimates show that we will finish off the year near break even. That will leave us with 265k in unrestricted reserves and 200K in capital reserves. Based on our funding profile we are receiving 220k in Covid mitigation support this coming year as well as 220k in Bridge Funding support this year. This keeps our revenue consistant with last years funding. Both of these grants will not be continued for the 2022-2023 school year. This provides us wth some significant risk as we move forward.

The air conditioning at the eduction center is still a work in progress, we are having issues with the original HVAC unit that was installed. We are looking at options to have boosters provide more airflow to the office spaces.

5. Superintendent Report – Dale – School Start-up went well this year. We were the first to open our school in the province. In the absence of government guidelines we chose to adhere to the same COVID guidelines as last year. This will require a Board motion at the next board meeting.
